Going forward, both companies will operate under the name of McVantage of Guyana, Inc. Also, we changed our logo as seen above to reflect our interdependence and projected strength of both companies.

One advantage of this amalgamation will mean that McVantage now has access to the diverse, strong product-lines and marketing strategies that WoodsDirect has established over the years. The McVantage product-line will expand to include Sandura® Wallaba Shingles, round pilings, and other specialty products such as fenders, rainscreen siding, internal paneling and flooring. Our other standard products will also include large timbers, dimensional lumber and decking.
